# Independent Auditor's Report

# Report on the Audit of the Financial Statements

#### Opinion

We have audited the accompanying financial statements of the company Health Initiative S.A. (the Company), which comprise the statement of financial position as at December 31, 2019, the statement of profit or loss for the year then ended, as well as the related notes.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the company Health Initiative S.A. as of December 31, 2019, and of its financial performance for the year then ended in accordance with the provisions of L. 4308/2014 as in force.

# Basis for opinion
